KHON-TV HEREBY AMENDS ITS FORM 388 DTV QUARTERLY ACTIVITY REPORT TO ADVISE THE COMMISSION THAT IT ENDED ITS CONSUMER EDUCATION EFFORTS ON JANUARY 15, 2009 - THE DAY THAT FULL-POWER TELEVISION STATIONS IN HAWAII COMPLETED THEIR DTV TRANSITION. IN LIGHT OF THE STATE'S EARLY DTV TRANSITION, THE STATION SOUGHT WAIVER OF POST-TRANSITION CONSUMER EDUCATION OBLIGATIONS.
